Aviation	Air traffic management (ATM) systems make sure the safety of whole flight in our sky. ATM systems process real-time surveillance and tracking data and integrate those data, flight plan and weather information which is sent from other civil air navigation service providers (ANSPs). Those systems process large volumes of data at high speed, stably and efficiently 24 hours a day, 365 days a year. We provide critical products and services that support air traffic controllers who take care that aircraft are safely separated and traffic flow is smooth and efficient.
Automotive	Motor vehicle inspection and registration are crucial for the owners of motor vehicles in Japan. The motor vehicle inspection and registration system is operated actively to assist the motor vehicle administration. This system is regularly reworked and synchronized with the latest developments in motorization to improve its performance and responsiveness to current trends. We contribute to this domain by making proactive proposals, many of which have been accepted.
Judicial	When constructing an environment for a society of safe living, based on law is important. We, as a member of the NTT DATA Group, participate widely in the proposals, development and operation of the system in order to further improve the convenience of the judicial systems to become the basis for our society.
Intellectual property	The intellectual property field that supports the business activities of companies is facing drastic changes due to globalization of businesses and the economic growth of Asian countries, including China, in recent years. In the intellectual property field, with these kinds of drastic changes, we, as a member of the NTT DATA Group, have been involved in the development of a system for patent administration right from the introduction of IT. We have played a part in conducting an application and examination business for patents, utility models, designs and trademarks in a stable and prompt manner, while contributing at the same time to the development and operation of the systems that respond to the business trends and changes in the intellectual property field.
Infrastructure / Network	We provide various systems for communication networks to support societal information infrastructures accurately and securely for a wide base of clients, right from the central government and local governments to private enterprises.
Risk management / Disaster prevention	NTT DATA i provides a disaster reduction communication system for more efficient communication with residents in the event of a disaster. Using the two-way communication of an IP network, this system sends voice message from loudspeakers and various messages from a diversity of media, including tablet PCs. In the event of a major disaster, through this system, local governments can grasp the whole picture of damages and a citizen can easily receive information about the damage and recovery status of this area.

Trade / Logistics	Similar to other countries worldwide, international logistics are conducted on a global scale in Japan, day and night. Associated ministries/agencies and industries work assiduously to realize prompt international logistics. Trade/logistics processing systems NTT DATA i works on play a part in these logistics. These systems play a role in supporting associated business operations by connecting customs, administrative institutions, and private enterprises online and promptly processing operations related to import and export.
Public accounting	The government accounting system standardizes and improves the efficiency of accounting processes for the unified control of Japanese government entities, ranging from revenue and expenditure to settlement. We, as a member of the NTT DATA Group, are developing and operating a system to further improve the convenience of the government accounting system. We also provide a large number of accounting systems for prefectures, cities, Tokyo's special wards, and independent administrative institutions for supporting people's daily lives.
Services for residents	NTT DATA i processes the business operations of local governments efficiently and participates in various systems to provide a wide range of administrative services in order to realize safer, more convenient, and prosperous local communities. We are also working on improving the quality and speed of administrative services by increasing the efficiency of information management for the internal business processing of local governments and by accelerating processing speeds using electronic settlement.
Tax affairs	To facilitate the process of tax filing for both central and local governments electronically, we are helping to develop and operate optimal services responsive to the business operations and needs of various clients. These services help make people's lives better.
Social insurance	To realize and maintain the smooth operation of the social insurance system, it is crucial to record and maintain member information accurately and safely. Naturally, the database is immense and complex, covering more than 100 million people, which makes it one of the largest public systems in Japan. We, as a member of the NTT DATA Group, are involved in a broad range of businesses associated with this field, including system development and operations.
Labor insurance	As a member of the NTT DATA Group, we play a major part in developing and operating labor insurance systems and labor environment management to further improve the convenience of the labor administration services.
Medical care / Welfare	Japan has a national health insurance system. Japanese people generally are enrolled in health insurance, and medical expenses are compensated by insurance. The patient pays a portion of the medical expenses to the hospital, and the remainder is charged to an insurance provider, such as a health insurance association, by the hospital. As a member of the NTT DATA group, we offer the following options for health insurance: 'Health Insurance Associations and Mutual Aid Associations We are engaged in the development and operation of core systems for the health insurance associations/societies of private enterprises and the mutual aid associations of civil servants. 'Examination and Payment Agency for Insurance Claims We provide a system for this specialized agency to examine whether the medical expenses billed by a hospital are accurate, and allow for proper review of medical expenses and quick payment to hospitals, etc.
